2023 Annual Report Nationally, in 2022, there were **30,339** teens in foster care ages 12 and older waiting to be adopted, but only **8,316** of them were adopted.* In other words, less than a third of older children ever find adoptive families. The rest remain in care until they age out.

In 2022, only 922 seventeen-year-olds were adopted anywhere in the US.

A Game-Changing Introduction Leads to Adoption

Christina and Steve Levendosky knew they wanted to adopt an older child to grow their family. Christina had always had a heart for it. When they understood they wouldn't easily have biological children, they began discussing adoption more seriously.

Their case manager at Barker Adoption Foundation suggested they consider meeting teens who are in foster care, which led them to DCFYI. Their lives have changed dramatically – and positively – since that day in early 2022.

"I met DJ at my first event," recalls Christina of the boy who was 16 and not too talkative. "We talked a little but not too much. DJ was very quiet. He's an introvert."

Christina became a regular at DCFYI events. Then Steve met DJ in July at a Nats game attended by other DCFYI youth and volunteers, and the two bonded over their love of baseball.

DJ's DCFYI mentor, Heather, was a wonderful support for all of them. "Heather guided me through a lot of what teenagers are like," says Steve. "She was a huge advocate for DJ. That was invaluable, that someone was there for him."

"By the summer, we were starting to think strongly about whether we were a good fit for DJ, and about what he wanted and needed in a family," Christina says.

The couple followed DCFYI's guidance to not tell the teen they were considering adoption. They talked with DI's case worker about his needs and whether they would be the right parents for him. The social worker also talked to DJ about his thoughts and feelings toward adoption. They believed their parenting style would suit him, and they knew that he was, as Christina says, "a great kid, and we loved him."

Christina and Steve were approved as DI's adoptive parents that fall and he moved in with them the following March. His adoption was finalized in the fall of 2023, only a year and a half from the day Christina and DI first met.

"Our lives have become very DJ-centric," says Steve. "After the first few months, it would have seemed strange without him."

DJ realized a long-held dream when, in the spring of his junior year at his new high school, he tried out for and made the varsity baseball team. The team went all the way to the state tournament. From his spot on third base, DJ found another family in the baseball team.

In the summer, DJ does normal teen stuff. Take a family vacation to Wisconsin. Go rafting for the first time. Attend adoption camp. And it's all because Christina and Steve's adoption case manager knew of DCFYI.

"I'm a huge fan of DCFYI, for multiple reasons," Christina says, noting that the opportunity to meet teens in person, through low-pressure events, was a game-changer.

"We would never have met DJ without DCFYI.

being shared. And most importantly, DJ on paper is different from DI in real life," says Christina. "DJ in person is a real person. Being able to meet him and know how wonderful he is. we're so grateful."



Your Support Matters!

In 2023, we successfully maintained programming through a long and unexpected gap in staffing. By revising staff positions and new hires, we are now staffed to better meet youth needs. Two staff members are former DCFYI participants, bringing their own lived experience to better support both youth and volunteers.

We revised aspects of the Open Table program based on youth experience and feedback from the first year of implementation. Several youth who thought they wanted Tables decided it wasn't the right time. We will create Tables for them when they're ready. Since youth participation in all DCFYI programming is voluntary, we allow youth to join us when the time is right and step back as they choose.

Support from generous donors like you kept eight young adults from becoming homeless. Through our Fund for Critical Youth Needs, these youth who had aged out of foster care were able to obtain first apartments or remain in their current housing. We also helped four other youth with transportation to or materials they needed to start new jobs.
